# Council Joins Knights on Bikes



**F**lorida Knights on Bikes from across the state celebrated the opening of Daytona Beach's Bike Week with a special event to recognize the newest Kob council within the Orlando Diocese.

SK Leo Decker, Grand Knight of Father Downey Council 4934, requested a Knights on Bikes designation for his council, based at Sacred Heart Catholic Church in New Smyrna Beach. Council Warden SK Shane Harrington of Council 4934 was appointed the Council's Road Captain by the Orlando Diocese Chairman SK Miles Brooks.

The event began with Knights on Bikes officials SK Ernie Jackson, Assistant Diocesan Chairman, and SK Dave Vaden, the Council 8086 Council Road Captain, designating Council 4934 as an official Knights on Bikes Council. The Catholic riders had their bikes blessed by Council 4934 Chaplain Rev. Fr. Aldrin Nunes. Then, Harrington and SK Rick Polo of Council 8086 led the group ride to the New Smyrna Speedway in Samsula to watch the Sons of Speed racing.

Sons of Speed is a motorcycle race inspired by early 20th-century board-track racing, featuring stripped-down bikes starting with pre-1925

American V-Twin engines up to antique 1200cc bikes, traveling over 80 miles per hour. Numerous modifications are made to handlebars, exhaust, fenders, fuel, and oil tanks etc. OH, did I mention NO BRAKES!

After watching motorcycle racing, the Knights on Bikes Group attended Mass celebrated by Fr. Charlie Donovan at Sacred Heart, followed by dinner at the Lost Lagoon Restaurant, also in New Smyrna Beach.

SK George Lopez, KoB National Vice President, participated in the ride. He called this event the "Piston Ride" because it brought another Knights on Bikes Council into the Florida Knights on Bikes.

Knights on Bikes Florida is part of the International Knights of Columbus. The Knights on Bikes' goal is to spread the love of God and evangelize communities in Florida, all while sharing the passion of motorcycles with fellow brothers. To do that, however, Councils need to help us by filling out the State Awards forms available online. We must have these forms by early April, so that we have time to evaluate the submissions and order the appropriate awards. You can't get recognized if you don't participate, so please—get those State Awards forms in!

I am also very happy to announce that Father Alberto Hernández, Rector and President of the St. Vincent de Paul Regional Seminary, has agreed to be our guest speaker at the Saturday evening banquet!

I pray that your Lenten journey continues to be spiritually rewarding for you, and I wish each of you a joyous and Blessed Easter!

# Remember That You Are Dust

Allow me to repeat what I told the young people whom I met in Lisbon last summer: "Let us find the courage to see our world, not as being in its death throes but in a process of giving birth, not at the end but at the beginning of a great new chapter of history. We need courage to think like this" – Message of the Holy Father for Lent 2024

**W**hen you received ashes on Ash Wednesday, you might have heard the words: "Remember that you are dust, and to dust you shall return." These words are jarring to the senses. What went through your head when those words were uttered? Me, dust? And that's what I'm returning to? It is a message that reminds us of our mortality, that compared to God we are indeed dust, and hopefully this all leads to a humility that sets the tone for Lenten repentance.

At the same time, we cannot forget that we are God's beloved, that the world was created for us. God sent his only begotten son as our savior and did not spare his life for our account. What a God we have, so far above us and almighty, and yet so intimate and accessible.

There's an old story among Jewish rabbis about a faithful Jew who every morning would write down on a piece of paper the words "I am but dust and ashes" and place the paper in his pocket.

Throughout the day he would take out the paper and read it; the words, spoken by Abraham in the Book of Genesis, served as a prayerful reminder of his unworthiness and humility before God.

One day he showed the paper to his rabbi. The rabbi was moved by his congregant's reverence.

But the rabbi took out a second piece of paper and wrote the words "For my sake, the universe was created." "Take these words as well and carry them too," the rabbi said. "Let there be balance in your life. Realize that of

yourself before God, you are nothing – but because you are created in God's image, out of love, you possess the greatest dignity imaginable: you are a child of God."

May we find in this Lenten desert experience a balance between those two truths in the spirituality we live. As we make our way through these days culminating in Holy Week and Easter at month's end, may we humble ourselves

and draw nearer to the God who embraces us in love. May these days draw us closer to Christ and more dedicated to His service as faithful Knights!

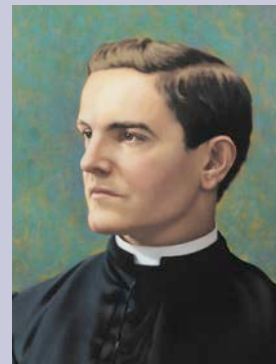
## Prayer for the Canonization of Blessed Michael J. McGivney

# Council Honors First Responders



It takes a special person to serve as a first responder - to be willing to run towards an accident, inside a burning building, or respond when shots are fired, when everyone else is running away. To honor those individuals, Knights of Columbus St. Cloud/Kissimmee Council 6624 held its annual Heroes Night Social, inviting all the local agencies in Osceola County's law enforcement, corrections, and fire departments for a night of appreciation and a banquet of tasty entries and desserts.

"Tonight is our way of saying 'Thank you' for your dedication. It is our way of recognizing all your agencies and to show our appreciation for all that you do to keep us safe", said Joe Martin, the event's Master of Ceremonies and Council lector. The Heroes Night Social was held just days after the memorial service for Florida Highway Patrol trooper Zachary Fink, who was killed in the line of duty in Fort Pierce, and a tragic incident in Minnesota where three first responders lost their lives as a reminder of the dangers they face every day.

One of the highlights of the evening is when each Chief recognized his or her 2024 Hero of the Year and provided a short back story as to why this Hero was chosen. Here are a few examples: Osceola

County Corrections Officer Juan Rodriguez, while working in one of the Correction facilities high-risk units for the most violent inmates, noticed that a fellow officer was having a medical episode and in distress. Officer Rodriguez never hesitated and jumped into action, saving her life. Afterwards, the Hero responded, "I did what I was trained to do. I was happy to be there to save her life." Another example was from the St. Cloud Fire Department Paramedic/Firefighter Jaycius Golding. While on a medical call to save a child from drowning, the child needed to be airlifted to the hospital, but the mother wasn't wearing the correct shoes to fly with her son. Without hesitation, Paramedic Golding gave the mother his shoes to wear so she could accompany her son to the hospital.

At the end of the ceremony, Joe Martin invited everyone to come to this year's Hero Casino Night, scheduled for Saturday, April 27, at the Council 6624 headquarters at 2000 Neptune Rd, Kissimmee. All the proceeds go to the benevolent fund for first responders and their families during time of need. Then as a surprise, Grand Knight, Robert Consolo, acknowledged the birthday of Osceola County Sheriff, Marcos Lopez, who despite other plans for the evening, made time to attend the event.



# Central Laps for Life



**P**ushing a wheelchair carrying a portrait of Msgr. Edward J. Thompson, State Advocate Bob Rasch gave his friend a ceremonial lap around the Bishop Moore Catholic High School track in Orlando during the March 2 11th annual Central Florida Laps for Life.

“I’m taking my friend for a lap around the track,” SK Rasch said.

Msgr. “Easy Ed” Thompson passed away on Feb. 11, 2016. The award for the top fund-raising KofC Council is named in his honor.

SK Bob – spiritually joined by “Easy Ed” – was one of more than 300 participants who raised more than \$92,400 (the total continues to grow) to support Ultrasound and Aid and Support After Pregnancy (ASAP) in Central Florida and beyond. Fund raising continues through March 29.

“I’d like to thank all the councils who supported Central Florida Laps for Life,” said event chairman SK Jamie Taglia. “The mostly cloudy skies made for a slightly cooler morning than last year – a great day for families to gather and give witness to the defense of life. It was a wonderful celebration of life from the games with the kids to the face painting to the wonderful food prepared by the

CCW of St James and the hamburgers, hotdogs, empanadas, breakfast burritos and pulled pork sandwiches. There were almost 300 participants. We walked over 390 miles if we added all the laps together. This means that our cumulative walk would take us from Orlando to Marathon Key. Several pregnancy centers had exhibits where they presented information about their ministries.”

Deacon Tony Medina of St. Mary Magdeline set the tone for the event when he explained in his invocation that billions of dollars were being spent in attempts to find life on Mars and farther out in the galaxy.

“You don’t need a Hubble Telescope when you can easily find new life using an ultrasound machine.”

In all, 23 teams signed up for the event, including 16 KofC councils. Leading the list was Incarnation #16236, raising \$20,806. Second, with \$16,745, were donations in Easy Ed’s honor, with Father Richard J. Lyons Council 5357 third with \$12,724. Councils are asked to reach out to SK Taglia regarding allocating their funds to ultrasound or ASAP.

# Challenging The Demands Of The Season

“Improving Emotional and Spiritual Aspects of Celebrating the Holidays.”

**T**his rather long title intended to cover what many people experience particularly during the holiday season and with the particular intention to provide some sense of ease in dealing with the stress and pressures that seem to arrive at this time of the year.

We were privileged to have two highly respected individuals: Dr. Elssy Oms, MD and Father Timothy Canaan, M.Div., M.A., to address this seminar to the many diverse parishioners who attended.

Dr. Oms is board certified in General Psychiatry and Child Adolescent Psychiatry and has previously served as the Vice Chair of Psychiatry at JFK North Medical Center in West Palm Beach.

Father Canaan has served the Diocese of Ogdensburg as Vocations Director, Director of Admissions of Wadhams Hall Seminary and as College and Director of Campus Ministry. He has preached numerous parish missions including at Emmanuel Parish where we are proud of his weekly participation at our weekly and Sunday masses.

Dr. Oms provided an introspective audio/video presentation of various topics dealing with the emotional feelings and ways to reduce stress usually experienced at this time of the year

In one of her topics, Dr. Oms explained that not all stressors are within our control, but some are; that putting too much on your plate may increase one’s stress load and limit the amount of time spent on self-care. One way she emphasized to help reduce stress may be to say “no” more often. This is especially true if you take on more than you

can handle because juggling many responsibilities, especially during this Christmas season, may leave you feeling overwhelmed. Indeed she went so far to say that “NO” is in fact a complete sentence requiring no further detail or explanation; that creating boundaries — especially with people who add to your stress levels — is a healthy way to protect your well-being.

She also went on to explain that exercise, a balanced diet, and more time out for meditation and prayer along with more time with family and friends could and would go a very long way to dealing with and reducing stress.

Even Father Canaan recounted to us that he himself went through some difficult and troubling periods in his life, But, in the telling us of his personal experiences and struggles he indeed provided emotional and spiritual encouragement to all of us listening to what he had encountered and how he overcame them particularly through prayer and the help of the Holy Spirit.

It was a much uplifting and rewarding seminar. Dr. Oms and Fr. Canaan indeed connected with each of us attending and their answers to questions were concise and on point. In addition to them both, much thanks also need go to our Faith Director, Armando Minutoli, who chaired the occasion and to our Council Treasurer, Peter Cavanaugh, who co-chaired along with Past Grand Knight and Membership Chairman Chuck Dolce who arranged for the refreshments.

All in all, the seminar was a huge success, close to one-hundred fifty knights and parishioners attended and all left with a strong feeling of composure, with a heightened sense of well-being and gratitude to what had been presented and with what each of those in attendance experienced. Brother Armando, who was exceedingly happy about the turn-out, said that they intend to promote similar events in the future that encourage physical and spiritual well-being for the knights and parishioners alike.

# Assemblies Promote Suicide Awareness



**K**nights of Columbus Patriotic Fourth Degree Assemblies 1932, 2194, and 3297 will place 22 crosses a day for thirty days on St. Helen's Catholic Church, Vero Beach property bordering 20th Street to give us a visual idea about how significant the loss of veteran lives is due to suicide.

The participating Assemblies were: #1932 Father Charles D. Brady of Vero Beach; #2194 St. Williams of Sebastian; and #3297 Richard N. Allen of Vero Beach.

Since 9/11, more veterans have lost their lives to suicide than to combat. Knights of Columbus Fourth Degree Assemblies wants to change that and has invited [22aday.org](http://22aday.org) out of Ypsilanti, Michigan, to execute a thirty-day long experience that helps us understand the significance of the veteran suicide problem and helps us understand what we can do to combat this unnecessary loss of lives.

Beginning at noon on February 14 and every day for 30 days, citizens are encouraged to come out any of these days to learn more about veteran suicide and what can be done to prevent it. Those who have lost a veteran to suicide may also come to the location to write that veteran's name on a

cross so that we will never forget. You may also add branch of service, date of death, or other information.

[22aday.org](http://22aday.org) is a 501(c)(3) nonprofit whose objective is to reduce the prevalence of suicide among veterans by doing public awareness campaigns and by helping individuals discover

# St. Jude Relic Tours Florida

**F**rom September 2023 to May 2024, the right arm of Saint Jude Thaddeus, venerated in Rome from ancient times, will be on pilgrimage in the United States, making stops in 100 cities. The relic toured the state of Florida for seven stops throughout late February and early March, with the KofC Fourth Degree assisting at veneration.

One of the Church's most beloved saints, Saint Jude is the one to whom people turn when they are desperate and have tried everything else. When things seem lost or unbearable—when they seem hopeless—Saint Jude is the one to whom people often turn. His tomb rests in St. Peter's Basilica, but centuries ago his arm was removed and placed in a wooden reliquary carved in the shape of a priestly arm imparting a blessing. This is the first time the relic has been out of Italy. The tour offers a unique opportunity for people to experience a connection with one of the most venerated figures in history.

Florida stops included the Queen of Peace, Gainesville, Feb. 22; Basilica of St. Paul, Daytona Beach, Feb. 23; St. Jude Parish, Boca Raton, Feb. 24; St. Peter Parish, Jupiter, Feb. 26; St. Elizabeth Seton, Naples, Feb. 27; St. Paul Catholic Church, Tampa, Feb. 28; Cathedral of St. Jude the Apostle, St. Petersburg, Feb. 29; Blessed Trinity, Ocala,



March 1; and St. Joseph's Catholic Church, Jacksonville, March 2.

The tour visited the Basilica of St. Paul in Daytona Beach on Feb. 23, attracting the largest turnout in its 143-year history. Seven Sir Knights from four Assemblies stood guard as pilgrims waited two- to three-hours for veneration. The Basilica also installed high-definition cameras to livestream Friday evening's Mass, enabling more than 500 people to participate online.

"It is very humbling, but a privilege and an honor," Father Ken Gill, rector of the basilica, told Glenda Meekins of the Florida Catholic Media Staff. Father Gill received news of the basilica's selection as a host to the relic just after celebrating Mass on the feast day of St. Paul, Father Gill considers the basilica's participation as God's will stating "there are no coincidences in the spiritual life."

Companions of the Cross Father Carlos Martins, church custodian of the relic and director of Treasures of the Church, accompanied the relic throughout the tour and gave the homily during the evening Mass at the Basilica.

The relic is permanently displayed at the Dominican Shrine of St. Jude Thaddeus located in St. Pius V Parish in Chicago.
